Dear Commission Members:

The Ardmore Police Department has compiled a list of certain money or legal tender totaling \$26,011.65 that has come into the possession of the agency's Property Room which has been determined to be excess, obsolete, unserviceable, or surplus. This money or legal tender is no longer needed as evidence or for any other purpose in connection with any litigation.

An Order has been obtained from the Carter County District Court authorizing the transfer of such money or legal tender to the Municipal Court Clerk for deposit in the Municipal General Fund.

Staff respectfully recommends approval of the Resolution to declare the money or legal tender surplus in the amount of \$26,011.65 to be transferred and deposited into the Municipal General Fund.

1. The Ardmore Police Department has come into the possession of certain money or legal tender, to be described in detail hereinafter, the owner of which is unknown, or who has not claimed the money or legal tender, has been in custody of the Chief of Police for at least ninety (90) days and the money or legal tender is no longer needed to be held as evidence or for any other purpose in connection with any litigation.
2. Attached to this Application and made a part hereof is a list describing the money or legal tender amount which includes the date that the money or legal tender came into possession of the Chief of Police. The names of the owners or persons in last possession of this money or legal tender, and their addresses, are set out on the list or are unknown.
3. The Chief of Police requests the authority of the Court to transfer the money or legal tender to the municipal court clerk for deposit into the municipal general fund in accordance with 11 O.S. §34-104 (E).

WHEREFORE, the Applicant prays that the Court set this matter for hearing not less than ten (10) days nor more than twenty (20) days after the filing of this Application, and that after the hearing, that this Court grant the Applicant the authority to deposit said money or legal tender which is described in the attached list, into the municipal general fund as provided for by law.

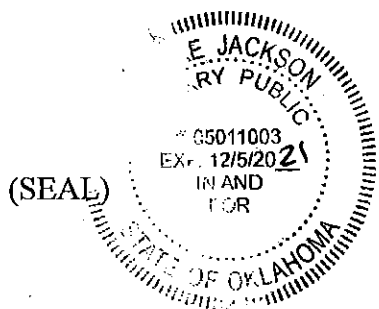




