Re: Rejection of the bid for Surplus Ammunition

Dear Commission Members:

The City of Ardmore recently solicited bids for the sale of surplus ammunition to the highest bidder.

Bids were solicited from eleven (11) vendors with two (2) bidders responding with a total of four bids. The highest bid was \$3,500.00 for 50,000 rounds of ammunition. The other three bids received were \$1,500.00 for 30,000 rounds, \$400.00 for 20,000 rounds and \$650.00 for 50,000 rounds. Staff evaluated the current state contract pricing for 50,000 rounds is between \$11,900.00 and \$23,350.00.


For this reason, staff believes it is in the City's best interest to reject all bids and rebid with a reserve as recommended by the City Attorney.
