
RE: Purchase of Duty Weapons (Glock 45 Gen 5) and Related Equipment

Dear Commission Members:

The Ardmore Police Department is requesting approval to purchase sixty (60) Glock 45 Gen 5 duty pistols with gun lights, holsters and sight sets valued at \$41,242.75. This purchase price is after the application of the trade-in agreement with GT Distributors for the Glock M17 Gen 5 duty pistols and ammunition valued at \$29,059.00. Funding for this purchase is from the GAPS Fund.

Staff respectfully recommends the purchase of the Glock 45 Gen 5 duty pistols and related equipment utilizing Oklahoma State Contract SW220 from GT Distributors of Pflugerville, TX in the amount of \$41,242.75.
