

ORDER AUTHORIZING SALE, DONATION OR DESTRUCTION OF PROPERTY

THIS MATTER, comes on for hearing this 11<sup>th</sup> day of Feb, 2022, on the Application of the Chief of Police of the City of Ardmore, Oklahoma, seeking authority to sell, donate or destroy personal property which has come into his possession. The Applicant appears in person. No one appears in opposition. The Court proceeded to examine the Notice and finds that the Notice of Hearing has been given according to the requirements of 11 O.S. §34-104.

IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED, by the Court that the Chief of Police is authorized to sell, donate or destroy the personal property for cash to the highest bidder after at least five (5) days' notice of the date, time, and place of the sale has been published in the Daily Ardmoreite.
